The new and improved heated indoor pool feels like a greenhouse you can swim in with the sunshine and plants, and there are wonderfully warm saunas in the locker rooms.

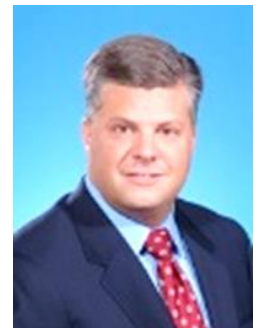

### Guest Passes

Each household is allowed to bring up to five guests. The daily rate at the pool is now \$3 per guest. Come to the office for your guest passes. It's \$10 for one guest pass or \$20 for two guest passes. We'll add one year to the current expiration date. **Five Year** Guest Passes are available at a reduced rate of **\$40 for 1** and **\$80 for 2**. NOTE: Activity Passes do not expire, but are \$5 to replace, if lost.

### REMEMBER:

**Bring your OWN\* Activity Passes!** Guests are limited to 5 per household. (\*NOTE: You can be suspended for up to 30 days for letting someone else use your pass or arguing with lifeguards.) See the bulletin board or website for complete **Pool Rules**.

## GREENWOOD NEWS

### The GVCA Semi-Annual Fee was Due July 1

The July 2018 semi-annual fee billing of \$227 was due July 1, 2018\*. Make Payee = "GVCA", 830 Village Club Drive, Sagamore Hills, OH 44067. Always include your GVCA account # on your check to ensure proper credit. Mail your check, drop it through the office door, or pay through your own online bill pay program. (PLEASE: To ensure your payment is received, mail or deliver it to the GVCA office, never hand your payment to employees or board members.)

\*NOTE: Last day to pay the fee without penalty was July 15, 2018, after which time a late fee of \$30 was added and the use of the facilities denied. Additional late fees of \$35 were added to unpaid accounts at the end of July and every month-end thereafter. After September 30, unpaid accounts were turned over for collection to the attorney, who places liens on the properties. All legal fees (such as \$95 for each legal notice sent, and \$250 to place & remove the lien) and court costs are the responsibility of owner and added to the amount you owe. Partial payments are applied first to late fees, then to legal fees, and lastly to GVCA semi-annual fees. If the balance owed is not paid in full by the deadlines above, the late & legal fees listed above will be added.

## GREENWOOD NEWS (continued)

### Old Carriage Trail Reminder: TRAIL CLOSED

**Reminder:** The Old Carriage Trail has been closed by the Cuyahoga Valley National Park (CVNP). Also closed is the GVCA connecting trail that starts at the Greenwood Parkway/Stoney Brook intersection. GVCA is allowing the CVNP's contractors to use this trail to reach the Old Carriage Trail. For safety, both trails will be closed for the duration of the project. The Old Carriage Connector Trail at the end of Holzhauser Road will be closed during construction hours, 7:00 am - 6:00 pm Monday to Friday, but can be used to access the Ohio & Erie Canal Towpath Trail after hours and on weekends. To avoid injury, please observe all warning signs and stay away from the trails and closed areas where crews are working.

**Update:** The four bridge sections were transported on a new temporary corduroy road to the bridge site in the forest and combined to build the new bridge frame, which was installed on the new foundations using two large cranes. The bridge deck and other finishing touches are now being installed. Greenwood Parkway eastbound between Pinewood View and Stoney Brook is closed for the duration of this project. Obey posted construction and traffic signs, and watch our website and Facebook page for updates.

### Reminder to Dog Walkers

If you are a dog owner, please be responsible and keep Greenwood beautiful!

#### When you walk your dog:

- **Know where you are allowed to walk your dog!** GVCA property is the only place usable by all dogs. The map is on the Greenwood website.

- Don't leave it, planning to "pick it up later."
- Throw it away at home or in a trash can!
- **Stay off other people's property. This includes condominium associations you do not live in!**
- Leash and control your dog at all times.
- Protect your dog from coyotes, raccoons and other dogs.

## **ACCES**

### **Tree Replacements:**

One of the goals of GVCA and ACCES is to maintain the number of trees in Greenwood Village. Each year approximately 40 requests for tree removals are reviewed and dispositioned by ACCES (or by the GVCA Manager on behalf of ACCES). When requests are approved, the resident or condominium association is required to plant a new tree at least four feet minimum on the property for each tree removed. To facilitate tracking of these replacements, future approvals will also require that the replacement tree(s) be planted within 90 days. Diagrams or photos of the property showing location of the replacement tree(s) must be submitted along with photographs of the tree(s). Residents or condominium associations can request extensions of the 90 days. Submittals requesting tree removals should clearly identify the trees and trees must be marked, preferably with a ribbon tied around them.

### **Surveillance Cameras:**

Over the past months the members of ACCES have reviewed the advances in surveillance cameras, along with the positive and negative impacts they have caused in other developments. To allow their use in Greenwood while minimizing the potential negative effects, ACCES adopted the rules in the next column, which were approved by the GVCA Board on October 16, 2018. If you wish to install a surveillance camera system, (or already have one) please read the rules carefully and then complete the Request for Approval form and submit it to ACCES:

## **SURVEILLANCE CAMERA RULES AND SUBMITTAL REQUIREMENTS - Approved October 16, 2018**

A maximum of three Surveillance Cameras per residence are permitted in Greenwood Village. Cameras may only be pointed at the front door and back door of a residence and, if applicable, at a side door. The following information must be submitted with the ACCES application for approval:

1. Description of Cameras
  - a. Name of manufacturer, model number, and literature showing pictures of the camera.
  - b. Size and technical data such as width and depth of field of view, resolution, image size.  
Note: Camera must be fixed and unable to move or rotate.
2. Location of Cameras on Residence
  - a. Plot Map showing your lot and neighboring lots, your home location and neighboring home locations that could be in the field of view, and each camera's location and direction it will be pointed.
  - b. Plot Maps are available at <http://summitmaps.summitoh.net/Parcel/Viewer>. The aerial photo must be included in the plot map to ensure the relative positions of the affected homes are shown accurately.
  - c. If you are not able to use the website, the GVCA Office can provide you with a Plot Map.
3. Mounting of Cameras on Residence
  - a. Description of how the camera will be mounted to the residence.
  - b. Description of the routing of electrical cable to the cameras, if any is required.  
Note: Cameras must be camouflaged and not visible from the street.
4. Approval of Neighbors and Condominium Association
  - a. Condominium owners must receive the approval of the Board of their Association before their application is submitted to ACCES.
  - b. Homeowners must receive the approval of their immediate neighbors, on all sides, and of any of their neighbors that might come in possible view of the camera's range.
5. Submittals after Cameras are Approved and Installed
  - a. Within 15 days after installation, photos of the cameras must be submitted to ACCES.
  - b. At the same time, screenshots, which show the images captured by the camera, must be submitted for each camera.
  - c. ACCES reserves the right to require modifications to the installation of the cameras if the screenshots show infringements on the privacy of adjacent residences (lot or dwelling) or if the camera captures an image of a common element.

### **Satellite Antennas**

For instant approval, use the new ACCES Individual Satellite Antenna Authorization Form at the GVCA Office or website under Forms. Fill out, initial, and sign that you will comply, and it's instantly approved when dropped at the GVCA Office. Make sure to answer all questions on the form completely.

### **ACCES APPROVAL**

Don't forget to submit a "Request for ACCES Approval" form. Additions or outside changes to existing lots or structures must be submitted in writing to Greenwood's Architectural Control Committee for Existing Structures (ACCES) for approval. The latest ACCES Rules are posted at [greenwoodohio.org](http://greenwoodohio.org). **Single-family homeowners** must have their neighbors' signatures on the form.

**Condominium owners** must have the written approval of their board or management company on the "Request for ACCES Approval" form before submission to the ACCES.

**Condominium associations or their management companies** also must submit a "Request for ACCES Approval" form to the ACCES and have it approved before beginning any outside projects.

The ACCES meets on the **first Tuesday of the month. The next ACCES submittal deadline is Tuesday, November 27, 2018.** The next ACCES meeting is on **Tuesday, December 4, 2018**, at 7:00 pm in the Garden Room. Approval Forms are at the GVCA office or on the website. **Don't forget Sagamore Hills zoning (330-467-0900) and Summit County building permits for your project!!!**
