**Proposed Tax Levy (Renewal)**

**A majority affirmative vote is necessary for passage.**

A renewal of tax for the benefit of the Cuyahoga Valley Career Center. An Ohio Vocational School District for the purpose of current expenses at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to 10 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2017, first due in calendar year 2018.
