

GVCA Pool COVID-19 Rules and Acknowledgement

The Greenwood Village Community Association pools are for the enjoyment of Residents and their guests. As always, SAFETY IS PRIORITY ONE. Because of the COVID-19 virus restrictions imposed by the State of Ohio, we have to implement changes in our operations and rules. Please read carefully and follow pool staff instructions. We need everyone to comply to protect residents and staff, and keep the pool open this summer.

Check-in and Check-out:

- **WARNING COVID-19 VIRUS MAY BE PRESENT; USE AT YOUR OWN RISK**
- Please stay home if you are sick. For those who are considered High Risk for contracting the Corona Virus Please Consider Not Entering the pool area so you may remain safe and healthy.
- There will be a non-contact forehead temperature scanner at check-in. Our staff must pass a temperature test before work and residents need to pass to gain entry to ensure all our protection (temperature may not exceed 100.4°). Wait until staff asks you to scan your forehead.
- Everyone must wear a mask **to enter and to exit** the pool area. Mask should be worn in public places of interaction and social distancing of a minimal of 6 feet is critical. Follow lane arrows and one way directions when entering, exiting, and using the pool facility. Masks are not required in the pool itself, or when you are sitting in your designated and restricted chair area.
- Remember to bring your activity pass to speed the check-in process.
- Checking out is Mandatory to ensure an accurate count of the number of people in the pool area. Do not leave until the pool staff have logged you out.

Guests:

- Every household is limited to 2 guests. To minimize handling of money at the gate, we strongly encourage residents to buy yearly guest passes in advance. Total guest limit is 50 in the pool area.

Designated Seating Areas for your Safety:

- There will be assigned seating in areas designated for singles, couples, and family groups. You are responsible for only using one chair in your assigned area. Gathering of groups from or of different households is prohibited. Chairs in an area will be sanitized by staff before the next resident is assigned to that area. Do not move chairs from their designated area.

Capacity:

- While chemicals in the pool water may kill more germs, please maintain social distancing of 6 feet. The pool can hold 110 if everyone is the proper distance, however, to leave enough room to swim around while maintaining social distancing, the lifeguards will limit the number of people in the pool.
- The pool deck can hold 70 people, and additional seating will be available in the lawn.

Toys Prohibited:

- Floats, including rafts and inner tubes, as well as water toys (dive sticks, balls, water guns) are prohibited. Individual pool equipment used for exercise (pool noodles, kick boards, pull buoys) or safety purposes (water wings, personal flotation devices) are permitted. GVCA will not supply noodles this year.

Facilities and Amenities Restrictions:

- The Village Club house is closed until further notice. There is no resident access. Portable toilets will be available and will have sanitizing gel for hand cleaning.
- The shuffleboard court is closed to provide more seating areas for residents.
- There will be no diving board. Diving is permitted off the side of the pool in the diving section.
- There will be no lap lanes during open swim this year, check the pool schedule for designated lap times.
- There will be no drinking fountain, please bring your own supply of drinking water or beverage.
- There will be **NO** "Lost and Found" bin. For safety, staff will dispose of any items left at the pool.

We realize these restrictions are a big change, but Greenwood residents are the best, so we know we will all work together to have a wonderful summer at the pool. We are all in this Together.

NOTE: Greenwood Village assumes no liability relative to COVID-19 and each person by entering the gated area acknowledges the risks of contracting any virus is always possible and cannot be completely eliminated.
